## 2021 FEES:

Subscriptions for IFRA UK Membership are based on turnover using the following sliding scale:

Annual Turnover /category	Subscription (net of VAT)
Consultant	£300.00
Associate	£1250.00
Direct member of IFRA	£2500.00
Full Member	0.13% of turnover with minimum of £500 and cap at £20k

Subscriptions are invoiced in January, with 50% of the payment due after 30 days and the other 50% due on 1<sup>st</sup> July.

## MEMBERSHIP

Membership of the Association shall be open to businesses in the United Kingdom and Eire as defined below: -

### 6.1 Membership Categories

#### 6.1.1 Full Membership

Open to those companies engaged in the production or marketing of fragrance compounds or fragrance ingredients.

#### 6.1.2 Associate Membership

Open to companies providing supporting services to those fulfilling the criteria of 6.1.1. Open to those businesses not covered by 6.1.1 or 6.1.2 but approved by the Executive

#### 6.1.3 Consultant Membership

Open to individuals acting as consultants to companies fulfilling the criteria of 6.1.1 or 6.1.2.

## Resignation

Resignations should be given in writing to the Secretariat by 30<sup>th</sup> September and will take effect at the end of the current calendar year. Resignations received after this date will take effect at the end of the following calendar year.

A member who leaves the Association by resignation, or for any other reason shall have no claim on the funds of the Association but shall remain liable for its subscription until the resignation takes effect.
